WOMAN'S CITY CLUB is pleased to host the Charter Committee's Centennial Celebration program with Rep. Rachel Roberts.

Rachel Roberts is an American politician serving as a member of the Kentucky House of Representatives, the first woman ever to hold the 67th district seat. She assumed office on March 3, 2020 and in 2023, became the Kentucky House Minority Whip, the fifth woman in the history of Kentucky to be elected to House leadership. Rachel is a



champion for health care, children, crime victims, public schools and teachers, and as a businesswoman, she is a strong voice for economic issues and job creation.

A native of Cincinnati, Roberts lives with her husband and their rescue pets in Newport, KY. She earned a Bachelor of Arts degree in marketing and business from Fort Lewis College in Colorado, and completed programs at the Harvard Kennedy School and Yale University.

The speaker for this program was originally to be former Cincinnati mayor Roxanne Qualls. We regret that due to a cycling accident, she is unable to appear on October 15, and we wish her a speedy recovery. We appreciate that Rachel Roberts is able to take Roxanne's place on such short notice and look forward to her presentation.

# President's Message THE POWER OF WOMEN VOTING

As I write this, we are a little more than a month out from the election on November 5. According to a report by the League of Women Voters of voters, in elections from 2004 through 2022, women voted at higher rates than men overall! Reports from the US Census from those years show that women registered to vote at higher rates than men. In several years, the discrepancy has been as high as 10 percentage points. (See https://www.lwv.org/blog/report-women-votersnumbers)

In 15 states, the proportion of women within the voter population was as high as 58% to 71%. In Ohio, the ratio of women voters is in the range of 47.0% to 52.2%, so turnout among women is very pivotal. Women have significant power over the outcomes of elections, and your vote is critically important in influencing issues that impact our lives such as reproductive rights, redistricting reform, the justice system and education.

The power of women will be featured in a talk by KY State Representative Rachel Roberts on October 15 co-presented by WCC with the Cincinnati Charter Committee. (See page 1.) Entitled "Women for Change," her remarks will discuss the significant role of women in improving the quality of life in Greater Cincinnati. She's sure to mention how Woman's City Club (WCC) contributed to reform of Cincinnati's government through the establishment of a new City Charter a century ago. WCC was also instrumental in creation of the country's first comprehensive City Plan in 1925.


WCC is a nonpartisan organization, so we don't endorse candidates, but we are cosponsoring two election-

# WOMEN RUNNING FOR OFFICE – ARE WE THERE YET?

## Monday, October 14, at 7pm via Zoom Co-Sponsored by WCC and Women in Film

## Join us for a non-partisan forum where women candidates discuss the unique advantages and challenges of running for office in 2024.

As a country, we have more women in politics than ever before, but are we there yet? In the U.S. Senate, 75% of seats are still held by men. With a woman running for President in 2024, just last year Pew Research found that only 18% of US adults said it's "extremely or very important" that a woman be elected president in their lifetime.

In Ohio, no Latina has ever served in the Ohio Statehouse. Women hold 28.8% of Ohio's legislative seats, ranking Ohio 36th out of 50 states, according to the Center for American Women in Politics.

Locally, the picture is brighter. In Hamilton County, women now hold more than half the elected positions, as well as 21 of 42 judicial seats. However, many still face gender discrimination they often find shocking. Consider the experience of first-time political candidate Karen Brownlee, running for Ohio Representative in the 28th district. "When I was out campaigning with my husband, the man we were telling about the campaign said, 'Who is going to cook dinner if you are running for office?' We have a long way to go to support women in politics," says Brownlee.

Judge Leslie Ghiz says she was sworn in holding one baby, with a toddler hanging onto her leg. Ghiz says, "I have wondered a million times, and still do, how in the world would a man be able to juggle that?"

Ghiz, Brownlee and many local female candidates will share stories in a nonpartisan forum hosted by Women in Film Cincinnati and Woman's City Club, free and open to the public.

## WCC Public Rally



## RALLY TO END GERRYMANDERING ATTRACTED 200

What began as a promise to Ohio Supreme Court Chief Justice Maureen O'Connor when she spoke at WCC's February 2023 program turned into a very public reality on Saturday, September 14 on Fountain Square. With the support of five other organizations, four speakers, and 3CDC, Woman's City Club held a rally in the heart of our city to educate, engage, and empower people to vote for Issue 1,the amendment O'Connor wrote to end gerrymandering in Ohio.

Because of our dedicated partners – **The Cincinnatus Association, Citizens Not Politicians, Common Cause, Greater Cincinnati Voter Collaborative, and League of Women Voters Ohio** – the event presented a strong lineup of inspiring and compelling speakers. Thanks to 3CDC waiving or reducing fees for use of the space and equipment, and its experienced staff's advice in planning, we met all our goals. Each partner had a tented table to promote its work and sign up members. Voter registration was available. The plaza accommodated a crowd and the main stage gave great visibility to the speakers.

Whistle Stop, an acoustic duo, opened the event and drew people to the Square with their music. Folksinger Chris Bieri performed her original song "The Gerrymander: The Monster That Ate Democracy." WCC President Beth Sullebarger welcomed people to the rally and introduced Vice Mayor Jan-Michele Lemon Kearney, who gave an official welcome on behalf of the



City of Cincinnati along with her strong personal endorsement of Issue 1. Beth followed up with more info about the event and why she supports the issue, and introduced **Catherine Turcer**, Executive Director of Common Cause, who got everyone fired up with chants of "Yes" and "Hell, YES!"

Rhonda Holyfield-Mangieri, president of The Cincinnatus Association, introduced celebrity guest Justin Jeffre, who spoke of his commitment to his hometown and the importance of fairness in government. Rhonda then explained why both Cincinnatus and she personally support Issue 1 before introducing Jen Miller, Executive Director of League of Women Voters Ohio. Jen's passionate call to action included solid reasons to support fair districts along with the chorus of "These Boots Were Made for Walking" and a reprise of Catherine's "Hell, Yes" chant. And last, but never least, **Susan** 



**Noonan** ended the presentations with a call to visit the tables, take home a sign or flyers, get registered to vote, and join one of the "amazing groups working to save democracy." People did indeed do that.



Jen Miller, who is also a pro at crowdcounting, estimated we had 200 people in the Square. The 3CDC staff members who were working the event each told us this was the biggest Saturday daytime event they have had on the Square. So it was indeed a success and worth all the time and effort so many of us put into planning and

We won't have fair districts until we give power to citizens, not politicians.

## WCC Member Profile



Even though an invitation to join is not necessary, it took two to bring Cheri Rekow, WCC Vice President of Civic Engagement, into the Woman's City Club. Tommie Thompson first introduced her to the club in the 1990s, and current president Beth Sullebarger asked her again last year.

Rekow said she "loves bringing her planning skills to anything she does with WCC — be it National Speaker selection or civic engagement leadership and discovering the skills, passions, and stories that every WCC member brings to the table.

She recently retired from the City of Cincinnati as a transportation and land-use planner, having spent 20 years in the Department of Transportation and Engineering. She gained early experience through the University of Cincinnati co-op program in the District of Columbia and Boston through the University of Cincinnati co-op program and studies abroad in Europe and the Middle East.

She lists her professional highlights as staff support for many downtown development projects, including The Banks, Riverfront, managing plans and strategies for City neighborhoods, Lunken Airport and a variety of multi-modal transportation projects. Her passion for research as data geek and Geographic Information System super-user (since 1993), was instrumental in bringing over \$388 million in funding to the city through successful grant writing. From UC's College of Design, Architecture, Art and Planning, Rekow received a B.S. in science and design and M.S. community planning. A Cincinnatian ever since, she grew up in



Northern Kentucky. Since retiring, she continues grant writing for City neighborhoods and other worthy causes – including WCC.

Rekow and her husband, Peri Georgiades, take joy in their three now-adult children and a new son-in-law, as they grow in their own fields of industrial design, medicine, and mechanical engineering/robotics. Motivated by her children, she has been a constant volunteer for and led a variety of youth-centered, religious and educational organizations, including PTA and scouting.

Rekow's creative outlets include being a multimedia amateur painter, sculptor and seamstress, and, since 2008, a periodic blogger through which she shares her sculpture and other ventures.

As a career public servant "and self-professed GDI," Rekow has "prided herself "on being non-partisan. Today a moderate, she sees a real need to "daylight the impacts of misinformation, extremism, and corruption on society, "especially on the least empowered." She sees WCC as a way to do that.


Between now and Election Day on November 5, please reach out to voters registered in Ohio to VOTE YES ON ISSUE 1. Because of early voting, please reach out sooner than later! The WCC Civic Engagement team challenges all WCC members to remind friends and family, in person or via social media, why they should care about gerrymandering and what they should know about Issue 1:

- The Issue 1 ballot language is intentionally confusing. Voting YES on 1 will end unfair districting.
- Gerrymandering is the political manipulation of voting district boundaries with the intent to unduly favor a party, group, or socioeconomic class.
- According to Newsweek, Ohio is among the 11 worst gerrymandered states along with North Carolina, Maryland, Pennsylvania, Kentucky, Louisiana, Arkansas, Utah, Texas, West Virginia and Wisconsin.

The graphic below and the source articles explain why Ohio's First District looks like it does today.




#### How Gerrymandering Affects Representation:



## GUNFIGHT: THE BATTLE OVER THE RIGHT TO BEAR ARMS IN AMERICA Reprint Edition 2018

## By Adam Winkler

*Gunfight* is a timely work examining America's four-centuries-long political battle over gun control and the right to bear arms. In this definitive and provocative history, Adam Winkler reveals how guns—not abortion, race, or religion—are at the heart of America's cultural divide. Using the landmark 2008 case *District of Columbia v. Heller*—which invalidated a law banning handguns in the nation's capital—as a springboard, Winkler brilliantly weaves together the dramatic stories of gun-rights advocates and gun-control lobbyists, providing often unexpected insights into the venomous debate that now cleaves our nation.

The book is available, likely on order, at local booksellers and through online booksellers. The Library has some hard copies of book, ebooks (currently all checked out), and audiobooks. Try to obtain the 2018 version.



Adam Winker is a lawyer and professor at the UCLA School of Law. His work has frequently been cited in judicial opinions, including in <u>Supreme</u> <u>Court</u> and numerous local courts. cases pertaining to the <u>First</u> and <u>Second</u> <u>Amendments</u>. Winkler's writing on the <u>right to bear arms</u>, which recognizes both the individual right to possess firearms and the legitimacy of effective gun control. His book *Gunfight: The Battle over the Right to Bear Arms in America* details the history of the right to bear arms and efforts to balance gun rights with gun safety laws in the United States since the country's founding.
